Resolution No. 2020-06-01

“RECOMMENDING THE AWARD OF CONTRACT TO NM MINI CONSTRUCTION SUPPLY UNDER SECTION 53.2 NEGOTIATED PROCUREMENT FOR EMERGENCY CASES FOR THE PROCUREMENT OF CONSTRUCTION MATERIALS FOR THE INSTALLATION OF TEMPORARY HOLDING AREA AT BUTUAN CITY SPORTS COMPLEX FOR THE ARRIVAL OF LOCALLY STRANDED INDIVIDUALS (LSIS) AND RETURNING OVERSEAS FILIPINOS (ROFs)”

WHEREAS, the Purchase Request of OCD Caraga for the procurement of construction materials for the installation of temporary holding area at Butuan City Sports Complex for the arrival of Locally Stranded individuals (LSIs) and Returning Overseas Workers (ROFs) was approved with an **Approved Budget Contract (ABC) of Eighty Three Thousand One Hundred Pesos Only (Php 83,100.00)** which is included in the QRF for COVID-19 pandemic.

WHEREAS, the Office of Civil Defense Caraga sent out the Request for Quotation (RFQ) directly to NM Mini Construction Supply on June 24, 2020.

WHEREAS, NM Mini Construction Supply was assessed as eligible supplier considering the completeness of documents and in accordance with the requirements. Thus, its financial proposal was evaluated as follows:

Bidder	Financial Proposal
NM Mini Construction Supply	60,680.00

WHEREAS, the offer made by NM Mini Construction Supply was determined by the BAC to be the Single Calculated Bid for the project.

WHEREAS, the post qualification at NM Mini Construction Supply was conducted by the PQ Team in accordance with Rule X, Section 34 of the Revised IRR of RA 9184 and submitted it to the BAC on March 24, 2020.

WHEREAS, **NM Mini Construction Supply** was determined and evaluated by the BAC as the most advantageous and economical to the government, thereby said proponent as the **Single Calculated and Responsive Bidder**;

WHEREAS, Section 12 of R.A. 9184 mandates that the OCD Caraga BAC shall recommend the award of the contract to the Head of the Procuring Entity or her duty authorized representative.

NOW, THEREFORE, for and in consideration of the foregoing, WE, the Members of BAC, hereby RECOMMEND to the Head of Procuring Entity (HoPE), the following:

- a. To declare **NM Mini Construction Supply** as the **Single Calculated Responsive Bidder** for the procurement of construction materials for the installation of temporary holding area at Butuan City Sports Complex for the arrival of Locally Stranded individuals (LSIs) and Returning Overseas Workers (ROFs); and
- b. The issuance of a Notice of Award (NOA) in favor of **NM Mini Construction Supply** in the amount of **Sixty Thousand Six Hundred Eighty Pesos Only**.
- c. **RESOLVED** this 25th day of June 2020 at the Office of Civil Defense Caraga, 109 T. Calo Extension, Philippines.
