**“RECOMMENDING PSI AIR 2007 INC AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT PROVISION OF AIR CARGO SERVICE FOR OCD COVID-19 RESPONSE AND THE ISSUANCE OF NOTICE OF AWARD”**

**WHEREAS**, on 16 March 2020 a state of calamity was declared in the entire Philippines pursuant to Proclamation No. 929 Year 2020 because of the Corona Virus Disease (COVID19). (**Annex A**);

**WHEREAS**, the Code Alert System for COVID-19 was raised to Code Red Sublevel Two (2) in accordance with the recommendation of the Department of Health (DOH) and the Inter-Agency Task Force for Emerging Infectious Diseases (IATF) because the number of confirmed cases of COVID-19 continues to rise;

**WHEREAS**, the provision of Air Cargo Service was urgently requested for fast bulk shipment and delivery of PPEs, health and food products to the different regions in order their distribution to the frontline hospitals, health facilities and holding centers would be facilitated;

**WHEREAS**, the Purchase Request from the GSD (**Annex B**) for the project “Provision of Air Cargo Service for OCD COVID-19 Response” with the Approved Budget for the Contract (ABC) of **Twenty-Five Million Pesos (PhP 25,000,000.00)** only will be charged from the OCD Quick Response Fund CY 2020 (**Annex C**);

**WHEREAS**, on 26 March 2020, the BAC recommended to the HoPE that the mode of procurement for the project is Section 53.2 (Emergency Cases) where the HoPE issued a Certification ascertaining the ground thereof (**Annex D**) and delegate the authority to the General Service Division (GSD) to conduct the Negotiation and endorse the award and all supporting documents through the BAC to ensure compliance with all the conditions and requirements provided for under RA 9184, its IRR and related guidelines;

**WHEREAS**, the deadline for the submission of eligibility and financial requirements of the project was on 6 April 2020 (**Annex E**);

**WHEREAS**, the quotations / acknowledgements were opened on said date with the following results (**Annex F**);
