“RECOMMENDING PAGODA PHILIPPINES INC. AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT SUPPLY AND DELIVERY OF ALCOHOL AND THE ISSUANCE OF NOTICE OF AWARD”

WHEREAS, on 16 March 2020 a state of calamity was declared in the entire Philippines pursuant to Proclamation No. 929 Year 2020 because of the Corona Virus Disease (COVID19). (**Annex A**);

WHEREAS, the Code Alert System for COVID-19 was raised to Code Red Sublevel Two (2) in accordance with the recommendation of the Department of Health (DOH) and the Inter-Agency Task Force for Emerging Infectious Diseases (IATF) because the number of confirmed cases of COVID-19 continues to rise and the Enhanced Community Quarantine was extended until 30 April 2020;

WHEREAS, the provision of alcohol was urgently requested for distribution and use of health and other frontline workers against COVID-19 as disinfectants to destroy bacterial and viral cells such as the COVID-19 virus;

WHEREAS, the Purchase Request from the GSD (**Annex B**) for the project “Supply and Delivery of Alcohol” with the Approved Budget for the Contract (ABC) of Two Million Two Thousand Three Hundred Ninety-Two Pesos (**PhP 2,002,392.00**) only will be charged from the OCD Quick Response Fund CY 2020 (**Annex C**);

WHEREAS, on 15 April 2020, the BAC recommended to the HoPE that the mode of procurement for the project is Section 53.2 (Emergency Cases) where the HoPE issued a Certification ascertaining the ground thereof (**Annex D**), and delegate the authority to the General Service Division (GSD) to conduct the Negotiation and endorse the award and all supporting documents through the BAC to ensure compliance with all the conditions and requirements provided for under RA 9184, its IRR and related guidelines;

WHEREAS, the deadline for the submission of eligibility and financial requirements of the project was on 17 April 2020 (**Annex E**);

WHEREAS, the quotations / acknowledgements were opened on said date with the following results (**Annex F**);

WHEREAS, Pagoda Philippines Inc. was evaluated by the GSD to be the Single Calculated Bidder;


WHEREAS, the GSD recommended that the **Pagoda Philippines Inc.** be declared as the **Single Calculated and Responsive Bidder** after checking and analyzing the documentary requirements by the OCD General Service Division. (**Annex G**);

NOW, THEREFORE, the BAC, after due deliberation resolved to recommend to declare **Pagoda Philippines Inc.** as the Single Calculated and Responsive Bidder;


FURTHER, We, the members of OCD-BAC hereby **RECOMMEND** to the HOPE the following;

- a. Approval of the recommendation to declare **Pagoda Philippines Inc.** as the Single Calculated and Responsive Bidder; and
- b. Issuance of a corresponding Notice of Award (NOA).


