“RECOMMENDING HAFID N’ ERASMUS CORPORATION AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT SUPPLY AND DELIVERY OF PERSONAL PROTECTIVE EQUIPMENT (PPE) AND THE ISSUANCE OF NOTICE OF AWARD”

WHEREAS, on 16 March 2020 a state of calamity was declared in the entire Philippines pursuant to Proclamation No. 929 Year 2020 because of the Corona Virus Disease (COVID19). (**Annex A**);

WHEREAS, the Code Alert System for COVID-19 was raised to Code Red Sublevel Two (2) in accordance with the recommendation of the Department of Health (DOH) and the Inter-Agency Task Force for Emerging Infectious Diseases (IATF) because the number of confirmed cases of COVID-19 continues to rise and the Enhanced Community Quarantine was extended until 30 April 2020;

WHEREAS, the provision of personal protective equipment was urgently requested for distribution as basic protection of medical personnel, responders, and other frontline units while rendering services amid Coronavirus Disease 2019 (COVID-19);

WHEREAS, the Purchase Request from the GSD (**Annex B**) for the project “**Supply and Delivery of Personal Protective Equipment (PPE)**” with the Approved Budget for the Contract (ABC) of **Forty-Two Million Four Hundred Fifty Pesos (PhP 42,450,000.00)** only will be charged from the OCD Quick Response Fund CY 2019 (**Annex C**);

WHEREAS, on 15 April 2020, the BAC recommended to the HoPE that the mode of procurement for the project is Section 53.2 (Emergency Cases) where the HoPE issued a Certification ascertaining the ground thereof (**Annex D**), and delegate the authority to the General Service Division (GSD) to conduct the Negotiation and endorse the award and all supporting documents through the BAC to ensure compliance with all the conditions and requirements provided for under RA 9184, its IRR and related guidelines;

WHEREAS, the deadline for the submission of eligibility and financial requirements of the project was on 17 April 2020 (**Annex E**);

WHEREAS, the quotations / acknowledgements were opened on said date with the following results (**Annex F**);

WHEREAS, during the opening of quotations/ offers for the project, **HAFID N' ERASMUS CORPORATION** and **CODO TRADING** have submitted complete documentary requirements needed for the determination whether they are legally, technically, and financially capable suppliers for the herein project;

WHEREAS, the GSD was not able to ascertain if **YSA SKIN CARE CORPORATION** and **RVN WREN SOLARA INC.** are legally, technically, and financially capable suppliers due to the absence of the documentary requirements;

WHEREAS, due to the urgent demand of the personal protective equipment (PPEs) **HAFID N' ERASMUS CORPORATION** was evaluated by the GSD to be the Lowest Calculated Bidder;

WHEREAS, the GSD recommended that **HAFID N' ERASMUS CORPORATION** be declared as the **Lowest Calculated and Responsive Bidder** adopting the Post-Qualification they had conducted on said establishment on 4 February 2020. **(Annex G)**;

NOW, THEREFORE, the BAC, after due deliberation resolved to recommend to declare **HAFID N' ERASMUS CORPORATION** as the Lowest Calculated and Responsive Bidder;

FURTHER, We, the members of OCD-BAC hereby **RECOMMEND** to the HOPE the following;

- a. Approval of the recommendation to declare **HAFID N' ERASMUS CORPORATION** as the Lowest Calculated and Responsive Bidder; and
- b. Issuance of a corresponding Notice of Award (NOA).
