**“RECOMMENDING CEBOOM ENTERPRISES AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT SUPPLY AND DELIVERY OF POLO SHIRT AND T SHIRT FOR USE OF STG LOGISTICS OFFICIALS AND PERSONNEL RE COVID-19 RESPONSE AND THE ISSUANCE OF NOTICE OF AWARD”**

**WHEREAS**, the BAC received a Purchase Request from the GSD (**Annex A**) for the project **“Supply and Delivery of Polo Shirt and T Shirt for use of STG Logistics Officials and Personnel re COVID-19 Response”** whose funding source is from the Reprogrammed Fund APB CY 2020 (**Annex B**);

**WHEREAS**, the Approved Budget for the Contract is One Hundred Five Thousand Pesos (**PhP 105,000.00**) only;

**WHEREAS**, in line with the principle of transparency and competitiveness, the RFQ was posted in the PhilGEPs website, in the OCD Website, and in the OCD Bulletin Board on 11 July 2020 (**Annex C**);

**WHEREAS**, the mode of procurement is Section 53.9 (Small Value Procurement) and the deadline for the submission of eligibility and financial requirements of the project was on 15 July 2020;

**WHEREAS**, the quotations / acknowledgements were opened on 16 July 2020 with the following results (**Annex D**);

**WHEREAS**, a Post Qualification (PQ) was conducted on 22 July 2020 by the OCD Central Office PQ Team composed of Mr. Sonny Patron, Mr. Jose Angelo Mangaoang, and Mr. Lariford Andrew Arvesu, supported by Mr. Jayson Timbal and Ms. Bebeth Gador of the BAC Secretariat. The PQ Team submitted a report to the BAC dated 23 July 2020, recommending the proponent as the Lowest Calculated and Responsive Bidder (**Annex F**);

**NOW, THEREFORE**, the BAC, after due deliberation resolved to recommend to declare **Ceboom Enterprises** as the Lowest Calculated and Responsive Bidder;

**FURTHER**, We, the members of OCD-BAC hereby **RECOMMEND** to the HOPE the following:

a. Approval of the recommendation to declare **Ceboom Enterprises** as the Lowest Calculated and Responsive Bidder; and

b. Issuance of a corresponding Notice of Award (NOA).
