OLD NDRRMC OPERATIONS CENTER BUILDING AND THE ISSUANCE OF  
NOTICE OF AWARD”**

**WHEREAS**, the BAC received a Purchase Request from the GSD (**Annex A**) for the project **“Procurement of Materials for the Repainting of OCD Admin and Old NDRRMC Operations Center Building”** whose funding source is from the OCD CY 2020 APB MOOE GASS

**WHEREAS**, the Approved Budget for the Contract is One Hundred Eighty-One Thousand Six Hundred Five Pesos (**PhP 181,605.00**) only;

**WHEREAS**, in line with the principle of transparency and competitiveness, the RFQ was posted in the PhilGEPS Website, in the OCD Website, and in the OCD Bulletin Board on 31 July 2020 (**Annex C**);

**WHEREAS**, the mode of procurement is Section 53.9 (Small Value Procurement) and the deadline for the submission of eligibility and financial requirements of the project was on 5 August 2020;

**WHEREAS**, the quotations / acknowledgements were opened on 6 August 2020 with the following results (**Annex D**):
