“RECOMMENDING VILLA SALUD CATERING SERVICES AS LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT PROVISION OF PACKED MEALS FOR THE SUPPORT PERSONNEL FOR HAULING AND REPACKING RE: COVID-19 RESPONSE (01 SEPTEMBER – 31 OCTOBER 2020)” AND THE ISSUANCE OF NOTICE OF AWARD”

WHEREAS, the Office of the President issued a Proclamation No. 922, declaring a State of Public Health Emergency throughout the Philippines due to prevalent pandemic brought about by the Corona Virus Disease 2019 (COVID 19). Further Proclamation No. 929 dated 16 March 2020 with subject “Declaring a State of Calamity throughout the Philippines due to Corona Virus Disease 2019” was issued due to the rapid increase of infection in the country (**Annex A and B**);

WHEREAS, the provision of packed meals was urgently requested for the needs of Haulers, Support Personnel and Repackers to ensure the healthiness of each frontliners;

WHEREAS, the BAC received a Purchase Request from the GSD (**Annex C**) for the project “**Provision of Packed Meals for the Support Personnel for Hauling and Repacking re: COVID-19 Response (01 September – 31 October 2020)**” whose funding source is from the OCD QRF 2020 (**Annex D**);

WHEREAS, the Approved Budget for the Contract is **Eight Million Four Hundred Eighteen Thousand (PhP 8,418,000.00)** only;

WHEREAS, on 29 August 2020, the BAC determined the mode of procurement to be Section 53.2 (Emergency Cases) compliance with all the conditions and requirements provided for under RA 9184, its IRR and related guidelines;

WHEREAS, the BAC TWG reported the result of negotiation with legally, technically and financially compliant suppliers showing **Villa Salud Catering Services** as the Lowest Calculated Bid (**Annex E**);
