**“RECOMMENDING MEIHAO CORPORATION AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT SUPPLY AND DELIVERY OF 180 TWO-CRANKS HOSPITAL BEDS FOR THE NAYONG PILIPINO MEGA QUARANTINE FACILITY AND THE ISSUANCE OF NOTICE OF AWARD”**

**WHEREAS**, the Office of the President issued a Proclamation No. 922, declaring a State of Public Health Emergency throughout the Philippines due to prevalent pandemic brought about by the Corona Virus Disease 2019 (COVID 19). Further Proclamation No. 929 dated 16 March 2020 with subject “Declaring a State of Calamity throughout the Philippines due to Corona Virus Disease 2019” was issued due to the rapid increase of infection in the country (**Annex A and B**);

**WHEREAS**, the provision of Hospital Beds is urgently requested for the use of day-to-day activities for the Nayong Pilipino Mega Quarantine Facility;

**WHEREAS**, the BAC received a Purchase Request from the GSD (**Annex C**) for the project “Supply and Delivery of 180 Two-Cranks Hospital Beds for the Nayong Pilipino Mega Quarantine Facility” whose funding source is from the Donated Funds for COVID-19 Response (**Annex D**);

**WHEREAS**, the Approved Budget for the Contract is **Two Million Nine Hundred Seventy Thousand Pesos (PhP 2,970,000.00)** only;

**WHEREAS**, on 12 August 2020, the BAC determined the mode of procurement to be Section 53.2 (Emergency Cases) compliance with all the conditions and requirements provided for under RA 9184, its IRR and related guidelines;

**WHEREAS**, the BAC TWG reported the result of the negotiation to legally, technically and financially compliant suppliers showing the following quotations for the project (**Annex E**):
