Resolution No. 2020-04-C-015

“RECOMMENDING CLEANWAY ENVIRONMENTAL MANAGEMENT SOLUTIONS INC. AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT PROVISION OF SANITATION AND DISINFECTION FOR THE FOUR (4) OCD BUILDINGS AND THE ISSUANCE OF NOTICE OF AWARD”

WHEREAS, on 16 March 2020 a state of calamity was declared in the entire Philippines pursuant to Proclamation No. 929 Year 2020 because of the Corona Virus Disease (COVID19). (**Annex A**);

WHEREAS, the Code Alert System for COVID-19 was raised to Code Red Sublevel Two (2) in accordance with the recommendation of the Department of Health (DOH) and the Inter-Agency Task Force for Emerging Infectious Diseases (IATF) because the number of confirmed cases of COVID-19 continues to rise and the Enhanced Community Quarantine was extended until 30 April 2020;

WHEREAS, the provision of sanitation and disinfection service was urgently requested for the cleaning and disinfecting of commonly touched surfaces and objects as a preventive measure towards the spread of the COVID-19 virus. Along this line, sanitation and disinfecting services is seen necessary to be conducted in the OCD Central Offices and the National Disaster Risk Reduction Management Operations Center (NDRRMOC) currently manned by OCD Skeletal Force and NDRRMC Augmentation Personnel;

WHEREAS, the Purchase Request from the GSD (**Annex B**) for the project “Provision of Sanitation and Disinfection for the Four (4) OCD Buildings” with the Approved Budget for the Contract (ABC) of **Ninety-Five Thousand Four Hundred Seventy-Two Pesos (PhP 95,472.00)** only will be charged from the OCD Quick Response Fund CY 2020 (**Annex C**);

WHEREAS, on 15 April 2020, the BAC recommended to the HoPE that the mode of procurement for the project is Section 53.2 (Emergency Cases) where the HoPE issued a Certification ascertaining the ground thereof (**Annex D**), and delegate the authority to the General Service Division (GSD) to conduct the Negotiation and endorse the award and all supporting documents through the BAC to ensure compliance with all the conditions and requirements provided for under RA 9184, its IRR and related guidelines;

WHEREAS, the deadline for the submission of eligibility and financial requirements of the project was on 17 April 2020 (**Annex E**);

WHEREAS, the quotations / acknowledgements were opened on said date with the following results (**Annex F**);

- b. Issuance of a corresponding Notice of Award (NOA).
