Resolution No. REGION-BARMM-06-020, s. 2020

“RECOMMENDING THE AWARD OF CONTRACT TO CLUSTERASIA CORP UNDER SECTION 53.2 NEGOTIATED PROCUREMENT FOR EMERGENCY CASES IN PROVISION OF PPEs IN SUPPORT FOR FRONTLINERS AND PERSONNEL OF OCD BARMM”

WHEREAS, the Purchase Request of the OCDRO-BARMM - Operation Section for the provision of PPEs in support for frontliners and personnel of OCD BARMM (Annex A) was approved on 24 June 2020 with an Approved Budget for the Contract (ABC) of One Million Two Hundred Ninety One Thousand Five Hundred Ten Pesos Only (Php1,291,510.00) which is included in the approved APB Fund 2020.

WHEREAS, the Office of Civil Defense (OCD) Region-BARMM sent out the Request for Quotation (RFQ) directly to Clusterasia Corp on 24 June 2020.

WHEREAS, the Clusterasia Corp was assessed as eligible supplier considering the completeness of documents and in accordance with the requirements. Thus, its financial proposal was evaluated as follows:

WHEREAS, the offer made by Clusterasia Corp was determined by the BAC-TWG to be the Single Calculated and Responsive Bidder.

WHEREAS, Section 12 of R.A. 9184 mandates that the Office of Civil Defense Bids and Awards Committee (OCD-BAC) shall recommend the award of contract to the Head of Procuring Entity or his/her duly authorized representative;

NOW, THEREFORE, for and in consideration of the foregoing, **WE**, the members of the OCD BARMM-BAC, hereby **RECOMMEND** to the Head of the Procuring Entity (HoPE), the following;

- a. To declare CLusterasia Corp as the Single Calculated and Responsive Bidder for provision of PPEs in support for frontliners and personnel of OCD BARMM; and
- b. The issuance of a Notice of Award (NOA) in favor of Clusterasia Corp in the amount of One Million Two Hundred Ninety One Thousand Five Hundred Ten Pesos Only (Php1,291,510.00).
