“RECOMMENDING TITANIUM CORPORATION – MY PLACE RESIDENCE HALL AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT PROVISION OF ACCOMMODATION AND MEALS FOR THE OUTGOING EMERGENCY MEDICAL TEAM (EMT) PERSONNEL DESIGNATED FOR COVID 19 QUARANTINE FACILITY AT WORLD TRADE CENTER (03 – 16 AUGUST 2020 AND 24 AUGUST 2020 – 06 SEPTEMBER 2020) AND THE ISSUANCE OF NOTICE OF AWARD”

WHEREAS, the Office of the President issued a Proclamation No. 922, declaring a State of Public Health Emergency throughout the Philippines due to prevalent pandemic brought about by the Corona Virus Disease 2019 (COVID 19). Further Proclamation No. 929 dated 16 March 2020 with subject “Declaring a State of Calamity throughout the Philippines due to Corona Virus Disease 2019” was issued due to the rapid increase of infection in the country (**Annex A and B**);

WHEREAS, the provision of accommodation was urgently requested for the use of Emergency Medical Team (EMT) in Quarantine Facility at World Trade Center;

WHEREAS, the BAC received a Purchase Request from the GSD (**Annex C**) for the project “**Provision of Accommodation and Meals for the Outgoing Emergency Medical Team (EMT) Personnel designated for COVID 19 Quarantine Facility at World Trade Center (03 – 16 August 2020 And 24 August 2020 – 06 September 2020)**” whose funding source is from the OCD Quick Response Fund 2020 (**Annex D**);

WHEREAS, the Approved Budget for the Contract is One Million Nine Hundred Seventy Three Thousand Four Hundred Pesos (**PhP 1,973,400.00**) only;

WHEREAS, on 21 July 2020, the BAC determined the mode of procurement to be Section 53.2 (Emergency Cases) and recommended the Delegation of Authority to the General Services Division (GSD) to conduct the Negotiation and all supporting documents to the HOPE, through BAC to ensure compliance with all the conditions and requirements provided for under RA 9184, its IRR and related guidelines;

WHEREAS, the General Services Division (GSD) submitted the result of their negotiation to legally, technically and financially compliant suppliers showing the following quotations for the project (**Annex E**):

- a. Approval of the recommendation to declare **Titanium Corporation – My Place Residence Hall** as the Single Calculated and Responsive Bidder; and
- b. Issuance of a corresponding Notice of Award (NOA).
