Resolution No. 2020-07-C-033

“RECOMMENDING MATTS’ CATERING AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT PROVISION OF CATERING SERVICES FOR THE STAFF AND PATIENTS AT COVID 19 QUARANTINE FACILITY – RIZAL MEMORIAL COLISEUM (RMC) (01-31 AUGUST 2020) AND THE ISSUANCE OF NOTICE OF AWARD”

WHEREAS, the Office of the President issued a Proclamation No. 922, declaring a State of Public Health Emergency throughout the Philippines due to prevalent pandemic brought about by the Corona Virus Disease 2019 (COVID 19). Further Proclamation No. 929 dated 16 March 2020 with subject “Declaring a State of Calamity throughout the Philippines due to Corona Virus Disease 2019” was issued due to the rapid increase of infection in the country (**Annex A and B**);

WHEREAS, the provision of Meals for the Staff and Patients were urgently requested to use in Quarantine Facility at Rizal Memorial Coliseum;

WHEREAS, the BAC received a Purchase Request from the GSD (**Annex C**) for the project “**Provision of Catering Services for the Staff and Patients at COVID 19 Quarantine Facility – Rizal Memorial Coliseum (RMC) (01-31 August 2020)**” whose funding source is from the OCD Quick Response Fund 2020 (**Annex D**);

WHEREAS, the Approved Budget for the Contract is Two Million Two Hundred Thirty Two Thousand Pesos (**PhP 2,232,000.00**) only;

WHEREAS, on 28 July 2020, the BAC determined the mode of procurement to be Section 53.2 (Emergency Cases) and recommended the Delegation of Authority to the General Services Division (GSD) to conduct the Negotiation and all supporting documents to the HOPE, through BAC to ensure compliance with all the conditions and requirements provided for under RA 9184, its IRR and related guidelines;

WHEREAS, the General Services Division (GSD) submitted the result of their negotiation to legally, technically and financially compliant suppliers showing the following quotations for the project (**Annex E**):

WHEREAS, four (4) other proponents tendered the same amount of **TWO MILLION TWO HUNDRED THIRTY TWO THOUSAND PESOS (PHP 2,232,000.00)**, namely: Matt's Catering, Meatcarver Incorporated, MikoStar Commercial and Restopreneur Management, Incorporated which were evaluated by the BAC to be the Lowest Calculated Bidder;

WHEREAS, to determine to whom the project will be awarded, the tie was broken through "draw lots" which was won by **Matt's Incorporated**;

NOW, THEREFORE, the BAC, after due deliberation resolved to recommend to declare **Matt's Incorporated** as the Lowest Calculated and Responsive Bidder;

FURTHER, We, the members of OCD-BAC hereby RECOMMEND to the HOPE the following;

- a. Approval of the recommendation to declare **Matt's Incorporated** as the Lowest Calculated and Responsive Bidder; and
- b. Issuance of a corresponding Notice of Award (NOA).
