“RECOMMENDING DLCL TRANSPORT AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT PROVISION OF SHUTTLE SERVICE FOR OCD PERSONNEL DURING THE COVID-19 PANDEMIC AND THE ISSUANCE OF NOTICE OF AWARD”

WHEREAS, the Office of the President issued a Proclamation No. 922, declaring a State of Public Health Emergency throughout the Philippines due to prevalent pandemic brought about by the Corona Virus Disease 2019 (COVID 19). Further Proclamation No. 929 dated 16 March 2020 with subject “Declaring a State of Calamity throughout the Philippines due to Corona Virus Disease 2019” was issued due to the rapid increase of infection in the country (**Annex A and B**);

WHEREAS, the provision of Shuttle Service for the OCD employees was urgently requested to provide transportation to OCD Personnel during COVID 19 Pandemic;

WHEREAS, the BAC received a Purchase Request from the GSD (**Annex C**) for the project “Provision of Shuttle Service for OCD Personnel during the COVID-19 Pandemic” whose funding source is from the OCD DRRM MOOE CY 2020 (**Annex D**);

WHEREAS, the Approved Budget for the Contract is Two Million Two Hundred Twenty Thousand Pesos (PhP 2,220,000.00) only;

WHEREAS, on 6 August 2020, the BAC determined the mode of procurement to be Section 53.2 (Emergency Cases) and recommended the Delegation of Authority to the Human Resource Management and Development Division (HRMDD) to conduct the Negotiation and all supporting documents to the HOPE, through BAC to ensure compliance with all the conditions and requirements provided for under RA 9184, its IRR and related guidelines;

WHEREAS, the Human Resource Management and Development Division (HRMDD) submitted the result of their negotiation to legally, technically and financially compliant suppliers showing the following quotations for the project (**Annex E**):

FURTHER, We, the members of OCD-BAC hereby **RECOMMEND** to the HOPE the following;

a. Approval of the recommendation to declare **DLCL Transport** as the Single Calculated and Responsive Bidder; and

b. Issuance of a corresponding Notice of Award (NOA).
