**Resolution No. 2020-04-01**

**“RECOMMENDING THE AWARD OF CONTRACT TO PHILAND PHARMACY AND GENERAL MERCHANDISE UNDER SECTION 53.2 NEGOTIATED PROCUREMENT FOR EMERGENCY CASES FOR THE PROCUREMENT OF PERSONAL PROTECTIVE EQUIPMENT (SURGICAL GLOVES, SURGICAL MASKS, KN95 MASKS AND 70% ALCOHOL, FACE SHIELDS AND THERMAL SCANNER) FOR COVID-19 DISASTER MANAGEMENT OPERATIONS”**

**WHEREAS**, the Purchase Request of OCD Caraga for the Procurement of Personal Protective Equipment (Surgical Gloves, Surgical Masks, KN95 Masks and 70% Alcohol, Face Shields and Thermal Scanner) for COVID-19 Disaster Management Operations was approved with an **Approved Budget Contract (ABC) of Eight Hundred Twenty Four Thousand Six Hundred Twenty Pesos Only (Php 824,620.00)** which is included in the approved APB Fund 2020.

**WHEREAS**, the Office of Civil Defense Caraga sent out the Request for Quotation (RFQ) directly to Philand Pharmacy and General Merchandise on April 13, 2020.

**WHEREAS**, Philand Pharmacy and General Merchandise was assessed as eligible supplier considering the completeness of documents and in accordance with the requirements. Thus, its financial proposal was evaluated as follows:

**WHEREAS**, the offer made by Philand Pharmacy and General Merchandise was determined by the BAC to be the Single Calculated Bid for the project.

**WHEREAS, Philand Pharmacy and General Merchandise** was determined and evaluated by the BAC as the most advantageous and economical to the government, thereby said proponent as the **Single Calculated and Responsive Bidder;**

**WHEREAS**, Section 12 of R.A. 9184 mandates that the OCD Caraga BAC shall recommend the award of the contract to the Head of the Procuring Entity or her duty authorized representative.

**NOW, THEREFORE**, for and in consideration of the foregoing, WE, the Members of BAC, hereby RECOMMEND to the Head of Procuring Entity (HoPE), the following:

**“A Service-Oriented Organization, A Prepared Population, A Safe Nation”**

- a. To declare **Philand Pharmacy and General Merchandise** as the **Single Calculated Responsive Bidder** for the Procurement of Personal Protective Equipment (Surgical Gloves, Surgical Masks, KN95 Masks and 70% Alcohol, Face Shields and Thermal Scanner) for COVID-19 Disaster Management Operations; and
- b. The issuance of a Notice of Award (NOA) in favor of **Philand Pharmacy and General Merchandise** in the amount of ***Eight Hundred Twenty Four Thousand Six Hundred Twenty Pesos Only (Php 824,620.00)***.
