“RECOMENDING THE AWARD OF CONTRACT TO D. PULVINAR TRANSPORT THROUGH NEGOTIATED PROCUREMENT UNDER EMERGENCY CASES (SECTION 53.2) FOR THE PROVISION OF TRUCKING SERVICES FOR THE HAULING AND DELIVERY OF PPEs FOR THE COVID-19 RESPONSE OPERATIONS OF OCDRO5”

WHEREAS, the Office of Civil Defense (OCD) Region V through the Bids and Awards Committee (BAC), undertook Alternative Mode of Procurement- Negotiated Procurement (Emergency Cases) for the procurement of the project **“PROVISION OF TRUCKING SERVICES FOR THE HAULING AND DELIVERY OF PPEs FOR THE COVID-19 RESPONSE OPERATIONS OF OCDRO5”** in accordance to Section 53.2 of the R.A. 9184 and its revised IRR;

WHEREAS, the Purchase Request No 2020-05-043 of the OCDRO-V – Operations Section for the **PROVISION OF TRUCKING SERVICES FOR THE HAULING AND DELIVERY OF PPEs FOR THE COVID-19 RESPONSE OPERATIONS OF OCDRO5** was approved on 04 May 2020 with an Approved Budget for the Contract (ABC) of **Six Hundred Thousand Pesos (Php600,000.00)**;

WHEREAS, the BAC directly negotiated with a supplier with technical, legal and financial capability to deliver the goods and perform the services to address the emergency;

WHEREAS, the office directly negotiated with **D. PULVINAR TRANSPORT**, and retrieved a price quotation together with the necessary documents;

WHEREAS, the bid proposal of the said bidder was found to be substantially complying;

WHEREAS, upon careful examination, validation and verification of all the documents submitted by the Bidder, its bid has been found responsive;

WHEREAS, **D. PULVINAR TRANSPORT** was determined and evaluated by the BAC-TWG to be legally, financially, and technically capable supplier for the said project;

WHEREAS, Section 12 of R.A. 9184 mandates the Office of Civil Defense 5 Bids and Awards Committee (OCDRO5- BAC) shall recommend the award of the contract to the Head of the Procuring Entity;

NOW, THEREFORE, for and in consideration of the foregoing, WE, the Members of the OCDRO5-BAC, hereby RECOMMEND to the Head of the Procuring Entity (HoPE), the following;

- a. To award to **D. PULVINAR TRANSPORT** the project PROVISION OF TRUCKING SERVICES FOR THE HAULING AND DELIVERY OF PPEs FOR THE COVID-19 RESPONSE OPERATIONS OF OCDRO5; and

- b. The issuance of Notice to Proceed (NTP) in favour of **D. PULVINAR TRANSPORT** in the amount of **Four Hundred Fifty Thousand Pesos (Php450,000.00) only;**



CONTRACT OF SERVICES

This **CONTRACT** entered into and executed this 05th of May in the year of Our Lord Two Thousand Twenty at Legazpi City, Philippines, by and between:

THE OFFICE OF CIVIL DEFENSE with office and postal address located at the Camp Gen, Simeon A. Ola, Legazpi City and represented herein by **CLAUDIO L. YUCOT**, Regional Director, and hereinafter referred to as the "**FIRST PARTY**"

-and-

D. PULVINAR TRANSPORT with office and postal address located at 1ST Our Lady's Village, Bitano, Legazpi, City and represented hereinafter by **DIOMY R. PULVINAR**, hereinafter referred to as the "**SECOND PARTY**"

WITNESSETH

1. That the **FIRST PARTY** has agreed with the **SECOND PARTY** that the latter shall provide trucking services to the **FIRST PARTY** for the hauling and delivery of PPEs from OCD Central Office, Camp Emilio Aguinaldo, Quezon City, Manila to OCDRO5, Camp Simeon Ola, Legazpi City, subject to the following prevailing rates:

Five (5) trips for Trucking Services

Location: Legazpi City- Quezon City, Manila- Legazpi City or any other provinces of Bicol Region

P90,000.00/trip

**with inclusion of roro, toll and parking fee as may be necessary*

2. That the **SECOND PARTY** is amenable that no date will be identified and will be coordinated prior the date of travel as directed by the end-user and will only render five (5) trips or as deemed necessary by the end-user for the **FIRST PARTY**.


3. **MANNER OF PAYMENT.** The **FIRST PARTY** agreed to pay the **SECOND PARTY** the total amount of **Four Hundred Fifty Thousand Pesos (P450,000.00)** only after the completion of the whole contract and within fifteen (15) working days after the submission of the billing statement including all other pertinent documents relative hereto.

Payment shall be made base on the actual services rendered by the **SECOND PARTY**. Any additional requirements and expenses incurred other than those already specified by the **FIRST PARTY** shall be charge accordingly.

3. **AMENDMENT.** No Modification of this **CONTRACT** shall be made except any amendment/s which shall be signed by both parties hereto.


