“RECOMMENDING MEIHAO CORPORATION AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT SUPPLY AND DELIVERY OF MEDICAL EQUIPMENT FOR COVID-19 QUARANTINE/TREATMENT FACILITIES AND THE ISSUANCE OF NOTICE OF AWARD”

WHEREAS, Republic Act 11494 was approved on 11 September 2020 with subject “Bayanihan to Recover As One Act” to provide COVID-19 Response and recovery interventions and to provide mechanisms to accelerate the recovery and bolster the resiliency of the Philippine Economy, Providing Funds therefor, and for other purposes;

WHEREAS, Proclamation No. 1021 was issued on 16 September 2020 extending the period of the State of Calamity throughout the Philippines due to Corona Virus Disease 2019 since the number of COVID 19 positive cases and deaths continue to rise despite the efforts and interventions to contain the same;

WHEREAS, the provision of medical equipment was urgently requested for the daily operations of COVID-19 Quarantine/Treatment Facilities;

WHEREAS, the BAC received a Purchase Request from the Task Group Facilities for the project “Supply and Delivery of Medical Equipment for COVID-19 Quarantine/Treatment Facilities” whose funding source is from the OCD QRF/NDRRMF (MOOE);

WHEREAS, the Approved Budget for the Contract is Two Million Seven Hundred Thirty Nine Thousand Seven Hundred Fifty Pesos (PhP 2,739,750.00) only;

WHEREAS, the mode of procurement is Emergency Cases of Republic Act. No. 11494: Bayanihan to Recover As One Act and the deadline for the submission of eligibility and financial requirements of the project was on 23 September 2020;

WHEREAS, the quotations / acknowledgements were opened on 23 September 2020 with the following results;
