Resolution No. 2020-09-02

“A RESOLUTION RECOMMENDING THE BUTUAN GRAND PALACE HOTEL AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT ON THE PROVISION OF ACCOMMODATION AND MEALS FOR COVID-19 ASYMPTOMATIC PATIENTS IN BUTUAN CITY FROM 01 OCTOBER 2020 TO 31 DECEMBER 2020 AND THE ISSUANCE OF NOTICE OF AWARD”

WHEREAS, the Republic Act 11494 otherwise known as the “*Bayanihan to Recover As One Act*” (Bayanihan 2) was approved on September 11, 2020 which provides COVID-19 response and recovery interventions as well as mechanisms to accelerate the recovery and bolster the resiliency of the Philippine economy, providing funds therefore, and for other purposes;

WHEREAS, the Proclamation No. 1021 entitled, “*Extending the Period of the State of Calamity throughout the Philippines due to Corona Virus Disease 2019 declared under Proclamation No. 929 s 2020*”, due to the continuous increase of COVID-19 cases and deaths in the country and to afford the national government and Local Government Units (LGUs) ample latitude to continue utilizing appropriate funds, including Quick Response Fund (QRF), in their disaster preparedness and response efforts to contain the spread of COVID-19, monitor and control prices of basic necessities and prime commodities, and provide basic services to the affected populations;

WHEREAS, as COVID-19 cases in Caraga Region continue to spike, isolation facilities have been overwhelmed as there have been 100% utilization rate of facilities particularly to areas which are officially declared by the Department of Health-Center for Health and Development (DOH CHD) Caraga with local transmission. The Local Government Units (LGUs) in the region have started converting gymnasiums, schools, and other government facilities to serve as isolation facilities for mild and asymptomatic cases which could be detrimental to the health condition of these COVID-19 patients as well as to health workers;

WHEREAS, with the effectivity of Bayanihan to Recover as One Act (Bayanihan 2), the Office of Civil Defense (OCD) is tasked to ensure the establishment of adequate and suitable isolation facilities and other requirements including billing of hotels, food, and transportation to be used by COVID-19 patients;

WHEREAS, during the previous meeting of the Regional Task Force (RTF) COVID-19, OCD Caraga expressed its commitment to provide assistance to LGUs identified as high risk with continued increase of COVID-19 positive cases due to local transmission;

WHEREAS, the LGU Butuan City has been officially declared by the DOH CHD Caraga with ongoing local transmission and has been identified by this regional office to be provided with support and assistance on isolation/quarantine facilities;

WHEREAS, the BAC received a Purchase Request from the OCD Operations Section for the project “**Provision of Meals and Accommodation for Asymptomatic COVID-19 Patients in Butuan City from 01 October 2020 to 31 December 2020**” of which funding source is from the QRF;

WHEREAS, the Approved Budget for the Contract is Seven Million Pesos (**PhP 7,000,000.00**) only while the mode of procurement is 53.2 Negotiated Procurement Emergency Cases of Republic Act. No. 9184;

WHEREAS, the quotation was opened on September 30, 2020 with the following result:

WHEREAS, **Butuan Grand Palace Hotel** was recommended by the BAC to be the Single Calculated and Responsive Bidder after the Business Permit, Omnibus Sworn Statement and Income Tax Return were completely submitted and deliberately evaluated;

NOW, THEREFORE, the BAC, after due deliberation resolved to recommend to declare **Butuan Grand Palace Hotel** as the Single Calculated and Responsive Bidder;

FURTHER, We, the members of OCD Caraga BAC hereby **RECOMMEND** to the HOPE the following;

- a. Approval of the recommendation to declare **Butuan Grand Palace Hotel** as the Single Calculated and Responsive Bidder; and
- b. Issuance of a corresponding Notice of Award (NOA).
