

CONTRACT OF SERVICE
(Provision of hotel/ venue/ accommodation)

KNOWN ALL MEN BY THESE PRESENTS:

This Contract of Service, made and entered into by and between:

The **OFFICE OF CIVIL DEFENSE**, a government agency with principal office and postal address at Camp General Emilio Aguinaldo, Quezon City herein represented by its Administrator, **USEC RICARDO B. JALAD**, of legal age, Filipino, hereinafter known as the **OCD**;

-and-

OCEANVILLE HOTEL AND SPA CORP. DOING BUSINESS UNDER THE NAME AND STYLE OF RIZAL PARK HOTEL with office and postal address at South Road Drive, T.M. Kalaw Ext. Ermita, Manila and herein represented by its Authorized Representative, **ANNA MARIE CHRISTINE UY**, of legal age, hereinafter known as the **"SERVICE PROVIDER"**;

RECITALS

WHEREAS, the **OCD** invited bids/quotations for the procurement project **"Provision of Accommodation for the BCDA and other Government Agencies Personnel designated for MOA Arena, Palacio de Manila and Lakeshore Swab Site (Enderun Mckinley Hill Mega Testing Sites)"** and has accepted a bid by **OCEANVILLE HOTEL AND SPA CORP. DOING BUSINESS UNDER THE NAME AND STYLE OF RIZAL PARK HOTEL** for the supply of those goods and services in the sum of **Two Million Eighty Thousand Pesos (₱2,080,000.00) only**, hereinafter called the **"CONTRACT PRICE"**;

NOW, THEREFORE, for and in consideration of the foregoing, the parties have agreed and stipulate as follows:

- SERVICE PROVIDER** must comply with Sixteen (16) rooms or provide the OCD with the following hotel/ venue/ accommodation requirements from 24 August 2020 – 13 October 2020 (50 nights):



3. **OCD** shall be charged by the **SERVICE PROVIDER** for the guaranteed number of guests or actual number whichever is higher;
 4. The payment due to the **SERVICE PROVIDER** shall be paid by the **OCD** within one (1) month after the receipt of the submitted progressive billing statement / statement of account chargeable against the OCD QRF 2020
 5. In case of breach of this Contract by the Service Provider, a penalty of one-tenth of one percent (0.001) of the total value of the goods/services purchased shall be deducted for each day of delay in the delivery of the goods/services ordered.
 6. If any dispute or difference of any kind shall occur between OCD and the SERVICE PROVIDER arising out of this contract, the parties shall make every effort to resolve amicably such dispute/difference by mutual consultation. Any and all disputes arising from the implementation of this Contract shall be resolved in accordance with R.A. 876, otherwise known as the "Arbitration Law" and R.A. 9285, otherwise known as the "Alternative Dispute Resolution Act of 2004". In case of a court suit arising from such dispute, controversy/claims, the venue shall be the courts of competent jurisdiction in Quezon City, to the exclusion of all other courts;

WHEREFORE, in consideration of the foregoing premises, the parties hereto have agreed to the abovementioned terms and conditions;


