WHEREAS, the BAC received a Purchase Request from GSD (Annex A) for the project **“Provision of Vehicle Rental for the Transportation Service for GSD Personnel for the Conduct of GSD Team Building”** whose funding source is from the AFMS APB CY 2019 (Annex B);

WHEREAS, the Approved Budget for the Contract is Twenty Six Thousand Pesos (PhP 26,000.00) only;

WHEREAS, in line with the principle of transparency and competitiveness, the RFQ was in the OCD Website, and in the OCD Bulletin Board on 06 June 2019 (Annex C);

WHEREAS, the mode of procurement is 53.9 (Small Value Procurement) and the deadline for the submission of eligibility and financial requirements of the project was on 11 June 2019;



- b. Issuance of a corresponding Notice of Award (NOA).


