"RECOMMENDING FALCON WATERFREE PHILIPPINES INCORPORATED AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT SUPPLY AND DELIVERY OF FALCON URINAL CARTRIDGE FOR THE REPLACEMENT OF URINAL CARTRIDGES OF SIX (6) URINALS AT MALE COMFORT ROOMS, OCD ADMIN BUILDING AND THE ISSUANCE OF NOTICE OF AWARD"

WHEREAS, the BAC received a Purchase Request from GSD (**Annex A**) for the project **"Supply and Delivery of Falcon Urinal Cartridge for the Replacement of Urinal Cartridges of Six (6) Urinals at Male Comfort Rooms, OCD Admin Building"** whose funding source is from the AFMS APB 2019. (**Annex B**);

WHEREAS, the Approved Budget for the Contract **Forty One Thousand Eight Hundred Fifty Six Pesos (PhP 41,856.00)** only;

WHEREAS, in line with the principle of transparency and competitiveness, the RFQ was posted in the OCD Website, and in the OCD Bulletin Board on 21 June 2019 (**Annex C**);

WHEREAS, the mode of procurement is Section 50 (Direct Contracting) and the deadline for the submission of eligibility and financial requirements of the project was on 26 June 2019;

WHEREAS, the **Falcon Waterfree Philippines Incorporated** submitted their technical and financial quotation prior the set deadline on 26 June 2019 (**Annex D**);

WHEREAS, **Falcon Waterfree Philippines Incorporated** was evaluated by the BAC to be the **Single Calculated Bidder** with an offer of **Forty One Thousand Eight Hundred Fifty Six Pesos (PhP 41,856.00)** (**Annex E**);

WHEREAS, the BAC dispensed with the ocular visit as other means of post qualification may be conducted through document review to determine and verify the authenticity of the submitted eligibility documents;


NOW, THEREFORE, the BAC, after due deliberation resolved to recommend to declare **Falcon Waterfree Philippines Incorporated** as the Single Calculated and Responsive Bidder;

FURTHER, We, the members of OCD-BAC hereby **RECOMMEND** to the HOPE the following;


- a. Approval of the recommendation to declare **Falcon Waterfree Philippines Incorporated** as the Single Calculated and Responsive Bidder; and
