“RECOMMENDING HSH AUTO REBUILDERS AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT REPAIR OF OCD VEHICLE – TOYOTA LAND CRUISER WITH PLATE NO. NIM 504 AND THE ISSUANCE OF NOTICE OF AWARD”

WHEREAS, the BAC received a Purchase Request from the GSD (**Annex A**) for the project **“Repair of OCD Vehicle – Toyota Land Cruiser with Plate No. NIM 504”** whose funding source is from the AFMS APB CY 2020 (**Annex B**);

WHEREAS, the Approved Budget for the Contract is Two Hundred Four Thousand Five Hundred Twenty Five Pesos (**PhP 204,525.00**) only;

WHEREAS, in line with the principle of transparency and competitiveness, the RFQ was posted in the PhilGEPS Website, in the OCD Website, and in the OCD Bulletin Board on 23 July 2020 (**Annex C**);

WHEREAS, the mode of procurement is Section 53.9 (Small Value Procurement) and the deadline for the submission of eligibility and financial requirements of the project was on 29 July 2020;

WHEREAS, the quotations / acknowledgements were opened on 30 July 2020 with the following results (**Annex D**):
