“RECOMMENDING A&W TOURS EN TRANSPORT CORPORATION AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT PROVISION OF (VEHICLE RENTAL) TRANSPORTATION REQUIREMENT FOR THE CONDUCT OF FIELD VISIT OF THE OCD SERVICE AND REGIONAL DIRECTORS IN THE EMERGENCY LOGISTICS WAREHOUSE AND THE ISSUANCE OF NOTICE OF AWARD”

WHEREAS, the BAC received a Purchase Request from GSD (**Annex A**) for the project **“Provision of (VEHICLE RENTAL) Transportation requirement for the Conduct of Field Visit of the OCD Service and Regional Directors in the Emergency Logistics Warehouse”** whose funding source is from the Management Reserve Fund. (**Annex B**);

WHEREAS, the Approved Budget for the Contract is Forty Thousand Pesos (**PhP 40,000.00**) only;

WHEREAS, in line with the principle of transparency and competitiveness, the RFQ was posted in the OCD Website, and in the OCD Bulletin Board on 05 August 2019 (**Annex C**);

WHEREAS, the mode of procurement is 53.9 (Small Value Procurement) and the deadline for the submission of eligibility and financial requirements of the project was on 08 August 2019;

WHEREAS, the following project proponents acknowledged the RFQ as follows (**Annex D**);

WHEREAS, two (2) proponents tendered the same amount of **FORTY THOUSAND PESOS (PhP 40,000.00)**, namely: A&W Tours En Transport Corporation and Reia Rent A Car Services which were evaluated by the BAC to be the Lowest Calculated Bidder (**Annex E**);

WHEREAS, to determine to whom the project will be awarded, the tie was recommended to be broken by sheer luck through “draw lots” which was won by **A&W Tours En Transport Corporation**.

WHEREAS, the BAC adopted the Post Qualification (PQ) conducted by the OCD Central Office PQ Team composed of Mr. Relan Jay Asuncion, Ms. Leonila Dissanayake, and Mr. Ryan Paul Roxas, supported by Ms. Fay Ashley Mamangon of the BAC Secretariat on 07 June 2019, recommending the proponent as the Lowest Calculated and Responsive Bidder (**Annex F**);
