“RECOMMENDING BOSTON BUILDER’S CENTER AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT SUPPLY AND DELIVERY OF ELECTRICAL AND SANITARY MATERIALS AND THE ISSUANCE OF NOTICE OF AWARD”

WHEREAS, the BAC received a Purchase Request from GSD (**Annex A**) for the project “**Supply and Delivery of Electrical and Sanitary Materials**” whose funding source is from the AFMS APB CY 2019. (**Annex B**);

WHEREAS, the Approved Budget for the Contract is Forty Nine Thousand Seven Hundred Seventy Pesos (**PhP 49,770.00**) only;

WHEREAS, in line with the principle of transparency and competitiveness, the RFQ was posted in the OCD Website, and in the OCD Bulletin Board on 16 August 2019 (**Annex C**);

WHEREAS, the mode of procurement is 53.9 (Small Value Procurement) and the deadline for the submission of eligibility and financial requirements of the project was on 22 August 2019;
