“RECOMMENDING CARSAN AUTO SERVICE & TRADING CENTER AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT RE-UPHOLSTERY AND REPLACEMENT OF DEFECTIVE PARTS FOR THE ONE (1) UNIT OCD VEHICLE MITSUBISHI ADVENTURE XBT-702 AND THE ISSUANCE OF NOTICE OF AWARD”

WHEREAS, the BAC received a Purchase Request from the GSD (**Annex A**) for the project “**Re-upholstery and Replacement of Defective Parts for the one (1) Unit OCD vehicle Mitsubishi Adventure XBT-702**” whose funding source is from the AFMS APB CY 2019 - GASS. (**Annex B**);

WHEREAS, the Approved Budget for the Contract is Forty Six Thousand Eight Hundred Pesos (**PhP 46,800.00**) only;

WHEREAS, in line with the principle of transparency and competitiveness, the RFQ was posted in the OCD Website, and in the OCD Bulletin Board on 21 October 2019 (**Annex C**);

WHEREAS, the mode of procurement is 53.9 (Small Value Procurement) and the deadline for the submission of eligibility and financial requirements of the project was on 24 October 2019;
