“RECOMMENDING REYNALD TIRE SUPPLY AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT REPLACEMENT OF DEFECTIVE TIRES OF THE ONE (1) UNIT OCD VEHICLE NAMEDLY TOYOTA LAND CRUISER WITH PLATE NO. NIM-504 AND THE ISSUANCE OF NOTICE OF AWARD”

WHEREAS, the BAC received a Purchase Request from the GSD (Annex A) for the project “Replacement of defective tires of the One (1) Unit OCD vehicle namedly Toyota Land Cruiser with plate no. NIM-504” whose funding source is from the AFMS APB CY 2019. (Annex B);
