**OCD CARAGA BIDS AND AWARDS COMMITTEE**

**Resolution No. 2019-14**

**“RECOMMENDING THE AWARD OF CONTRACT TO MYLES DESIGNSHOP PLAQUES AND PRINTS UNDER SECTION 53.9 SMALL VALUE PROCUREMENT (NEGOTIATED PROCUREMENT) FOR THE PROCUREMENT OF 300 PIECES POLO SHIRTS FOR THE SECOND QUARTER NATIONWIDE SIMULTANEOUS EARTHQUAKE DRILL”**

**WHEREAS**, the Purchase Request of OCD Caraga for the provision of transportation services for procurement of 300 Pieces Polo Shirts for the Second Quarter Nationwide Simultaneous Earthquake Drill was approved with an **Approved Budget Contract (ABC) of Ninety Thousand Pesos Only (Php 90,000.00)** (Annex A) which is included in the approved APB Fund 2019 (Annex B).

**WHEREAS**, the Office of Civil Defense Caraga sent out the Request for Quotation (RFQ) invitations to at least three (3) probable providers in the area.

**WHEREAS**, three (3) prospective bidders, namely: Zhujar Manufacturing Incorporated, Sub30 Events and Prints and Aptex Textile Printing Corporation submitted their respective quotations and documents thereof prior to the opening of bids on April 26, 2019.

**WHEREAS**, Zhujar Manufacturing Incorporated and Sub30 Events and Prints were disqualified due to incomplete requirements submitted while Aptex Textile Printing Corporation was assessed to be the eligible suppliers considering the completeness of documents and in accordance with the requirements. Thus, its financial proposal was evaluated as follows:

**WHEREAS**, the offer made by Aptex Textile Printing Corporation was determined by the BAC to be the Single Calculated Bid for the project.

**WHEREAS**, the post qualification was conducted by the PQ Team in accordance with Rule X, Section 34 of the Revised IRR of RA 9184 and submitted it to the BAC on April 29, 2019.

**WHEREAS, Aptex Textile Printing Corporation** was determined and evaluated by the BAC as the most advantageous and economical to the government, thereby said proponent as the **Single Calculated and Responsive Bidder**;


**WHEREAS**, Section 12 of R.A. 9184 mandates that the OCD Caraga BAC shall recommend the award of the contract to the Head of the Procuring Entity or her duty authorized representative.

**NOW, THEREFORE**, for and in consideration of the foregoing, WE, the Members of BAC, hereby RECOMMEND to the Head of Procuring Entity (HoPE), the following:

- a. To declare **Aptex Textile Printing Corporation** as the **Single Calculated and Responsive Bidder** for the procurement of 300 Pieces Poo Shirts for the Second Quarter Nationwide Simultaneous Earthquake Drill; and
- b. The issuance of a Notice of Award (NOA) in favor of **Aptex Textile Printing Corporation** in the amount of **Eighty Five Thousand Five Hundred Pesos Only (P 85,500.00)**.


