**OCD CARAGA BIDS AND AWARDS COMMITTEE**

**Resolution No. 2019-06**

**“RECOMMENDING THE AWARD OF CONTRACT TO DADA TRANSPORT SERVICE UNDER SECTION 53.9 SMALL VALUE PROCUREMENT (NEGOTIATED PROCUREMENT) FOR THE PROVISION OF TRANSPORTATION SERVICE FOR THE OCD CARAGA FAMILY DAY ON MAY 02-03, 2019 IN SAN AGUSTIN, SURIGAO DEL SUR”**

**WHEREAS**, the Purchase Request of OCD Caraga for the provision of transportation services for **OCD Caraga Family Day on May 02-03, 2019 in San Agustin, Surigao del Sur** was approved with an **Approved Budget Contract (ABC) of Seventy Two Thousand Pesos Only (Php 72,000.00)** (Annex A) which is included in the approved APB Fund 2019 (Annex B).

**WHEREAS**, the Office of Civil Defense Caraga sent out the Request for Quotation (RFQ) invitations to at least three (3) probable providers in the area.

**WHEREAS**, three (3) prospective bidders, namely: BWS Travel and Services, Jai-Jai Travel and Services and Dada Transport Service submitted their respective quotations and documents thereof prior to the opening of bids on April 29, 2019.

**WHEREAS**, BWS Travel and Services and Jai-Jai Travel and Services were disqualified due to above ABC offers while Dada Transport Service was assessed to be the eligible suppliers considering the completeness of documents and in accordance with the requirements. Thus, its financial proposal was evaluated as follows:

**WHEREAS**, the offer made by Dada Transport Service was determined by the BAC to be the Single Calculated Bid for the project.

**WHEREAS**, the post qualification was conducted by the PQ Team in accordance with Rule X, Section 34 of the Revised IRR of RA 9184 and submitted it to the BAC on April 29, 2019.

**WHEREAS**, **Dada Transport Service** was determined and evaluated by the BAC as the most advantageous and economical to the government, thereby said proponent as the **Single Calculated and Responsive Bidder**;

**WHEREAS**, Section 12 of R.A. 9184 mandates that the OCD Caraga BAC shall recommend the award of the contract to the Head of the Procuring Entity or her duty authorized representative.

**NOW, THEREFORE**, for and in consideration of the foregoing, WE, the Members of BAC, hereby **RECOMMEND** to the Head of Procuring Entity (HoPE), the following:

- a. To declare **Dada Transport Service** as the **Single Calculated and Responsive Bidder** for the provision of transportation services for the OCD Caraga Family Day on May 02-03, 2019 in San Agustin, Surigao del Sur; and
- b. The issuance of a Notice of Award (NOA) in favor of Dada Transport Service in the amount of **Seventy Two Thousand Pesos Only (P 72,000.00)**.
