Resolution No. 2019-16

“RECOMMENDING THE AWARD OF CONTRACT TO DADA TRANSPORT SERVICE UNDER SECTION 53.9 SMALL VALUE PROCUREMENT (NEGOTIATED PROCUREMENT) FOR THE PROVISION OF TRANSPORTATION SERVICE FOR THE SECOND QUARTER NATIONWIDE SIMULTANEOUS EARTHQUAKE DRILL ON JUNE 18-21, 2019 IN BAYUGAN CITY, AGUSAN DEL SUR ”

WHEREAS, the Purchase Request of OCD Caraga for the provision of transportation services for the Second Quarter Nationwide Simultaneous Earthquake Drill on June 18-21, 2019 in Bayugan City, Agusan Del Sur was approved with an **Approved Budget Contract (ABC) of One Hundred Twenty Three Thousand Pesos Only (Php 123,000.00)** (Annex A) which is included in the approved APB Fund 2019 (Annex B).

WHEREAS, the Office of Civil Defense Caraga sent out the Request for Quotation (RFQ) invitations to at least three (3) probable providers in the area.

WHEREAS, three (3) prospective bidders, namely: Rodriguez Transport Service, Agnor PUV Transco and Dada Transport Service submitted their respective quotations and documents thereof prior to the opening of bids on June 17, 2019.

WHEREAS, Rodriguez Transport Service, Agnor PUV Transco were disqualified due to above ABC offers while Dada Transport Service was assessed to be the eligible suppliers considering the completeness of documents and in accordance with the requirements. Thus, its financial proposal was evaluated as follows:

Bidder	Financial Proposal
Dada Transport Service	123,000.00

WHEREAS, the offer made by Dada Transport Service was determined by the BAC to be the Single Calculated Bid for the project.

WHEREAS, the post qualification of the aforesaid bidder was dispensed due to the adoption of the previous post qualification last April 29, 2019.

WHEREAS, **Dada Transport Service** was determined and evaluated by the BAC as the most advantageous and economical to the government, thereby said proponent as the **Single Calculated and Responsive Bidder**;


WHEREAS, Section 12 of R.A. 9184 mandates that the OCD Caraga BAC shall recommend the award of the contract to the Head of the Procuring Entity or her duty authorized representative.

NOW, THEREFORE, for and in consideration of the foregoing, WE, the Members of BAC, hereby RECOMMEND to the Head of Procuring Entity (HoPE), the following:

- a. To declare **Dada Transport Service** as the **Single Calculated and Responsive Bidder** for the provision of transportation services for the Second Quarter Nationwide Simultaneous Earthquake Drill on June 18-21, 2019 in Bayugan City, Agusan Del Sur; and
- b. The issuance of a Notice of Award (NOA) in favor of Dada Transport Service in the amount of **One Hundred Twenty Three Thousand Pesos Only (P 123,000.00)**.
