"RECOMMENDING RM RELOS TRANSPORT SERVICE AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT PROVISION OF VAN RENTAL SERVICE FOR THE CONDUCT OF COMMUNITY FIRST RESPONDER TRAINING AND THE ISSUANCE OF NOTICE OF AWARD"

WHEREAS, the BAC received from the Capacity Building and Training Services (CBTS) Purchase Request (**Annex A**) for the project **Provision of Van Rental Service for the Conduct of Community First Responder Training** whose funding source is from the CY 2019 CBTS APB (**Annex B**);

WHEREAS, the Approved Budget for the Contract is **Thirty Six Thousand Pesos (PhP 36,000.00)** only;




