“RECOMMENDING REIA RENT A CAR SERVICES AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT PROVISION OF TRANSPORTATION REQUIREMENT FOR THE CONDUCT OF RDANA AND PDNA TRAINING AND THE ISSUANCE OF NOTICE OF AWARD”

WHEREAS, the BAC received a Purchase Request from CBTS (**Annex A**) for the project **“Provision of Transportation Requirement for the conduct of RDANA and PDNA Training”** whose funding source is from the CBTS CY 2019 APB. (**Annex B**);

WHEREAS, the Approved Budget for the Contract is Forty Eight Thousand Pesos (PhP 48,000.00) only;

WHEREAS, in line with the principle of transparency and competitiveness, the RFQ was posted in the OCD Website, and in the OCD Bulletin Board on 11 September 2019 (**Annex C**);

WHEREAS, the mode of procurement is 53.9 (Small Value Procurement) and the deadline for the submission of eligibility and financial requirements of the project was on 16 September 2019;
