**WHEREAS**, the BAC received from the Operations Service Purchase Request Number OPCEN 042019-001 (**Annex A**) for the project **Provision of Meals for Post Evaluation Meetings for the Finalization of Final Reports 2018 and First Quarter 2019** whose funding source is from the CY 2019 OS APB (**Annex B**);
