WHEREAS, the BAC received a Purchase Request from Operations Service (Annex A) for the project “Provision of Transportation (Vehicle Rental) for the Conduct of Reports Development Training” whose funding source is from the OS APB CY 2019. (Annex B);

WHEREAS, the Approved Budget for the Contract is Thirty Nine Thousand Pesos (Php39,000.00) only;

WHEREAS, in line with the principle of transparency and competitiveness, the RFQ was posted in the OCD Website, and in the OCD Bulletin Board on 04 May 2019 and 10 May 2019 (Annex C);

WHEREAS, the mode of procurement is 53.9 (Small Value Procurement) and the deadline for the submission of eligibility and financial requirements of the project was on 08 May 2019 and was extended until 15 May 2019;




