WHEREAS, the BAC received a Purchase Request from PAO (**Annex A**) for the project **“Supply and Delivery of Drawstring Bag for OCD’s Participation in the 3rd Tactical, Survival and Arms Expo”** whose funding source is from the Management Reserve Fund (MRE) (**Annex B**);

WHEREAS, the Approved Budget for the Contract is Forty Five Thousand Pesos (**PhP 45,000.00**) only;

WHEREAS, in line with the principle of transparency and competitiveness, the RFQ was posted in the OCD Website, and in the OCD Bulletin Board on 25 October 2019 (**Annex C**);

WHEREAS, the mode of procurement is 53.9 (Small Value Procurement) and the deadline for the submission of eligibility and financial requirements of the project was on 30 October 2019;
