**“RECOMMENDING AFP COMMISSIONED OFFICERS COUNTRY AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT PROVISION OF MEALS FOR EMERGENCY NDRRMC FULL COUNCIL MEETING REGARDING THE DECLARATION OF NATIONAL DENGUE EPIDEMIC AND THE ISSUANCE OF NOTICE OF AWARD”**

**WHEREAS**, the BAC received a Purchase Request from PDPS (**Annex A**) for the project **“Provision of Meals for Emergency NDRRMC Full Council Meeting regarding the declaration of National Dengue Epidemic”** whose funding source is from the OCD QRF CY 2019 (MOOE). (**Annex B**);

**WHEREAS**, the Approved Budget for the Contract is Forty Six Thousand Five Hundred Pesos (**PhP 46,500.00**) only;

**WHEREAS**, in line with the principle of transparency and competitiveness, the RFQ was posted in the in the OCD Website, and in the OCD Bulletin Board on 5 August 2019 (**Annex C**);

**WHEREAS**, the mode of procurement is 53.2 (Emergency Cases) given that the intended use is for the conduct of NDRRMC Emergency Full Council Meeting for the proposed declaration of State of Calamity related to Dengue Epidemic;

**WHEREAS**, the deadline for the submission of eligibility and financial requirements of the project was on 6 August 2019;

**WHEREAS**, the **AFP Commissioned Officers Country** submitted its proposal amounting to **Forty One Thousand Two Hundred Nine and 79/100 Pesos (PhP 41,209.79)** only (**Annex D**);

**WHEREAS**, **AFP Commissioned Officers Country** was evaluated by the BAC to be the Single Calculated and Responsive Bidder, given past transactions of the agency and the proponent being of known eligibility as a government facility;

**NOW, THEREFORE**, the BAC, after due deliberation resolved to recommend to declare **AFP Commissioned Officers Country** as the Single Calculated and Responsive Bidder;

**FURTHER**, We, the members of OCD-BAC hereby **RECOMMEND** to the HOPE the following:

- a. Approval of the recommendation to declare **AFP Commissioned Officers Country** as the Single Calculated and Responsive Bidder; and
- b. Issuance of a corresponding Notice of Award (NOA).
