“RECOMMENDING R.M. RELOS TRANSPORT SERVICE AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT PROVISION OF TRANSPORTATION FOR THE CONDUCT OF FY-2020 OCD APB VALIDATION WORKSHOP AND THE ISSUANCE OF NOTICE OF AWARD”

WHEREAS, the BAC received a Purchase Request from PDPS (**Annex A**) for the project **“Provision of Transportation for the conduct of FY-2020 OCD APB Validation Workshop”** whose funding source is from the PDPS APB CY 2019. (**Annex B**);

WHEREAS, the Approved Budget for the Contract is **Twenty Thousand Pesos (Php20,000.00)** only;

WHEREAS, in line with the principle of transparency and competitiveness, the RFQ was posted in the OCD Website, and in the OCD Bulletin Board on 23 August 2019 (**Annex C**);

WHEREAS, the mode of procurement is 53.9 (Small Value Procurement) and the deadline for the submission of eligibility and financial requirements of the project was on 28 August 2019;
