“RECOMMENDING 5J&C PLACE AND CATERING SERVICES AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT PROVISION OF MEALS FOR THE COMMEMORATION OF THE INTERNATIONAL DAY FOR DISASTER REDUCTION BACK TO BACK WITH THE ASEAN DAY FOR DISASTER MANAGEMENT (IDDR/ADDM) 2019 AND THE ISSUANCE OF NOTICE OF AWARD”

WHEREAS, the BAC received a Purchase Request from PDPS (Annex A) for the project “Provision of Meals for the Commemoration of the International Day For Disaster Reduction Back to Back with the ASEAN Day for Disaster Management (IDDR/ADDM)” whose funding source is from the PDPS APB CY 2019. (Annex B);

WHEREAS, the Approved Budget for the Contract is Forty Nine Thousand Five Hundred Pesos (Php49,500.00) only;

WHEREAS, in line with the principle of transparency and competitiveness, the RFQ was posted in the OCD Website, and in the OCD Bulletin Board on 30 September 2019 (Annex C);

WHEREAS, the mode of procurement is 53.9 (Small Value Procurement) and the deadline for the submission of eligibility and financial requirements of the project was on 3 October 2019;


